**EXPERIENCE AND TRAINING REQUIREMENTS**

Graduation from an accredited college or university with a Bachelor's Degree in Nursing and sufficient advanced, specialized nursing training to qualify for the State of Nevada certification as an Advanced Practitioner of Nursing with a subspecialty of pediatrics or family medicine

**LICENSE OR CERTIFICATE**

- Current licensure to practice as a Registered Professional Nurse in the State of Nevada
- Certified, or eligible for Certification, as a Nurse Practitioner with the State of Nevada Board of Nursing within three months of date of appointment
- Certified or eligible for Certification, to prescribe with the Nevada State Board of Pharmacy
- A valid driver's license is required at time of appointment
